- THE CLUB WILL NOT BE RESPONSIBLE FOR LOSS OR DAMAGE TO PROPERTY LEFT OR KEPT BY MEMBERS ON ANY PART OF THE SHATTUCK PROPERTY INCLUDING AUTOMOBILES
- NO PROPERTY OF THE SHATTUCK MAY BE REMOVED FROM COURSE GROUNDS OR PUT TO USE OTHER THAN WHICH IT WAS ATTENDED
- COST OF DAMAGES OF SHATTUCK PROPERTY CAUSED BY A MEMBER OR THEIR GUEST WILL BE CHARGED TO THE MEMBER RESPONSIBLE
- MEMBERS MUST CHECK IN WITH THE PRO SHOP BEFORE PLAYING AND MUST START AT HOLE 1 UNLESS INSTRUCTED OTHERWISE BY THE PRO SHOP
- PLAYERS ARE EXPECTED TO OBSERVE THE RULES OF GOLF, PARTICULARLY WITH REGARD TO THE ETIQUETTE OF THE GAME. ALL DIVOTS AND BALL MARKS ARE TO BE REPAIRED AND SAND TRAPS RAKED
- PRACTICE ON THE GOLF COURSE IS NOT PERMITTED AND THERE SHALL BE ONE BALL PLAYED PER GOLFER
- THE SUPERINTENDENT OR PERSON IN CHARGE HAS THE AUTHORITY TO DECIDE IF THE COURSE IS FIT FOR PLAY. IF THE COURSE HAS TO BE CLOSED, IT WILL BE REOPENED ONLY WITH APPROVAL OF THE SUPERINTENDENT/PERSON IN CHARGE.
- GREENS AND CART FEES WILL APPLY TO EACH MEMBER FOR NON MEMBER EVENTS/OUTSIDE OUTINGS/ CORPORATE EVENTS
- MANAGEMENT RESERVES THE RIGHT TO CLOSE THE COURSE DURING GOLF OUTINGS
- GOLF CARTS SHALL NOT BE DRIVEN BY ANYONE UNDER THE AGE OF 16 AND WITHOUT POSSESSION OF A VALID DRIVER'S LICENSE
- OPERATORS OF GOLF CARTS WILL BE HELD RESPONSIBLE FOR ANY DAMAGE CAUSED TO THE CART OR COURSE DUE TO NEGLIGENCE
- MEMBERSHIPS ARE **NON TRANSFERABLE AND NON REFUNDABLE**
- ALL ALCOHOL CONSUMED ON THE COURSE MUST BE PURCHASED FROM DUBLIN ROAD TAPROOM, NO OUTSIDE ALCOHOL OF ANY KIND ALLOWED. IF YOU ARE CAUGHT WITH OUTSIDE ALCOHOL YOU WILL BE SUSPENDED WITHOUT REIMBURSEMENT. ALL COOLERS ARE SUBJECT TO INSPECTION
